Specifications for the 30 Cal Service Rifle Match:

- Any US or Foreign 30 Cal Service Rifle (M14/M1A, M1 Garand, AR10, FAL, G3, AK47, 1903/1903A3, 1917, Enfield)
- Rifles may have Non-Standard Stocks and NM Accuracy Modifications.

Categories:

- Metallic Sights – Irons, (Receiver Sight may be used on 1903 Springfield)
- Optics – Any Magnification, (Scope or Aim Point/Red Dot)

Match will follow the CMP M14 Heritage Match Rules (M1A Match):

- Distance 300 Yards, Target SR-3
- 55 Rounds (5 Sighters/50 rounds for record)
- Electronic Targets

Match Course-of-Fire:

- 5 Sighting Shots and 20 shots, 300 yards, Slow Fire Prone, 25 Minutes.
- 10 shots, 300 yards, Rapid Fire Prone, 70 seconds.
- 10 shots, 300 yards, Rapid Fire Sitting, 60 seconds.
- 10 shots, 300 yards, Slow Fire Standing, 10 minutes.

Note: Rifles with Muzzle Brakes are not Allowed.

REGISTRATION: 07:00-0730, Firing starts at 08:00, (Note: Earlier Start Time because of Summer Heat)

SQUADDING: All matches will be squadded. Competitors will also score and be responsible for pit duties as necessary.

SAFETY FLAGS: Are required

AWARDS: *Metallic/Optical Match Winner's Will Be Recognized For Their Shooting Abilities.*

LOCATION: Worland Shooting Complex (WSC), from Worland go west on Hwy 20 to West River Road (WYO 433) turn right and go north approx. 1/3 of a mile then turn left onto 15 Mile Road at Washakie County Fairgrounds. Follow the road past the county shop. Take the paved road up the hill to the right (northerly), driving past the gravel pits. In approximately 1 mile, you should see the Worland Shooting Complex sign on the right. Follow the gravel road to the front gate.
